

## **Lall & Sethi Tsunami Relief Efforts**

- (i) INDIA - Adoption of an orphanage to look after children who have lost either one or both parents in the tragedy. In this regard, Rajesh Ramanathan from our Bangalore office is currently in Chennai, the capital of Tamil Nadu, which is the worst effected State in India, exploring which orphanage needs the maximum assistance. Lall & Sethi shall provide financial assistance to such an orphanage for an initial period of one year and make a long term commitment to the orphanage to fund the upbringing of at least 10 children till they achieve adulthood.
- (ii) SRI LANKA – Lall & Sethi, in co-operation with its associate in Sri Lanka shall donate the entire service charges for all trade mark work undertaken by us in Sri Lanka on behalf of our clients. Only the official fee and actual expenses incurred shall be retained by us / our associates.
